## LINK TO JOIN

1. The link to join the conference will be emailed from Zoom to your registered email address on

a) 29 September 2022 for Day 1 and

b) 30 September 2022 for Day 2.

- 2. You will receive 2 separate emails from the same email address for Day 1 and Day 2.
- 3. It is recommended to use the individual email address either personal or company's email BUT NOT the company's general email address.
- 4. If you are using the company's email address, please ensure that your company does not block the email from Zoom. Please check your spam mailbox as well.
