**AKTA PERKONGSIAN LIABILITI TERHAD 2012**

**PERATURAN-PERATURAN PERKONGSIAN LIABILITI TERHAD (PINDAAN) 2025**

PADA menjalankan kuasa yang diberikan oleh seksyen 91 Akta Perkongsian Liabiliti Terhad 2012 [Akta 743], Menteri membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Perkongsian Liabiliti Terhad (Pindaan) 2025.**

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 16 April 2025.

**Pindaan peraturan 7**

2. Peraturan-Peraturan Perkongsian Liabiliti Terhad 2012 [P.U. (A) 462/2012], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam peraturan 7, dengan menggantikan perkataan “empat belas” dengan perkataan “tiga puluh”.

**Pindaan Jadual**

3. Jadual kepada Peraturan-Peraturan ibu dipinda—

(a) dalam butiran 10, dengan menggantikan perkataan “RM5 setiap muka surat” dengan perkataan “RM10 per dokumen”; dan

(b) dengan memasukkan selepas butiran 18 dan butir-butir yang berhubungan dengannya butiran dan butir-butir yang berikut:

LIMITED LIABILITY PARTNERSHIPS ACT 2012

LIMITED LIABILITY PARTNERSHIPS (AMENDMENT) REGULATIONS 2025

IN exercise of the powers conferred by section 91 of the Limited Liability Partnerships Act 2012 [Act 743], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Limited Liability Partnerships (Amendment) Regulations 2025**.

(2) These Regulations come into operation on 16 April 2025.

**Amendment of regulation 7**

2. The Limited Liability Partnerships Regulations 2012 [P.U. (A) 462/2012], which are referred to as the “principal Regulations” in these Regulations, are amended in regulation 7, by substituting for the word “fourteen” the word “thirty”.

**Amendment of Schedule**

3. The Schedule to the principal Regulations is amended—

(a) in item 10, by substituting for the words “RM5 per page” the words “RM10 per document”; and

(b) by inserting after item 18 and the particulars relating to it the following item and particulars:

| "18A. | Publication or advertisement on the website of the Commission under section 76A of the Act | RM500". |
