Fellow and Associate members of MAICSA, with more than five years' practical tax experience, either in the public or private sector, are also eligible to apply to become tax agents under Section 153(3) of the Income Tax, 1967. The CGI qualification (**formerly the ICSA qualification**) is recognised as equivalent to an Honours Degree by the Public Services Department. MAICSA is also a founder member of **Corporate Secretaries International Association Limited (CSIA)**. CSIA, an international federation of governance professional bodies for corporate secretaries and governance professionals, is dedicated to developing and growing the study and practice of corporate secretaryship, to improve professional standards and the quality of governance practice, and organisational performance. In tandem with its mission of developing good corporate professionals, MAICSA is committed to maintaining the highest standard of integrity and ethical values within the corporate secretarial profession. MAICSA also acts as a change catalyst in the corporate arena, participating actively in the enhancement of corporate governance.
